This category is specifically for clients/participants of the project and does not include project employees who were formerly clients/participants, or board/consortia members who are not clients/participants of the project.
- ❖ **\$425 (Non- NHTA Members)** per person for participants from projects that have not paid their 2008/2009 dues to the Association or who are not affiliated with a Healthy Start project and/or are not a paid "Friend of Healthy Start."
